I, _____, do solemnly swear (or affirm) that I am a citizen of the United States and the state of Colorado, that I am an eligible elector who resides in the county of _____ or within the political subdivision; that I am a member of the _____ party (or that I am unaffiliated with a political party) as shown on the registration books of the county clerk and recorder; that I will perform the duties of judge according to law and the best of my ability; that I will studiously strive to prevent fraud, deceit, and abuse in conducting the same; that I will not try to determine how any elector voted, nor will I disclose how any elector voted if in the discharge of my duties as judge such knowledge shall come to me, unless called upon to disclose the same before some court of justice; that I have never been convicted of election fraud, any other election offense, or fraud and that, if any ballots are counted before the polls close on the date of the election, I will not disclose the result of the votes until after the polls have closed and the results are formally announced by the designated election official. (C.R.S. 1-6-114 (1))

To ensure fair and honest election results, I certify that:

1. If selected as an Election Judge, I will arrive at my designated location by the time assigned and remain until excused by the Supervisor.
2. I agree to remain apolitical and refrain from making personal opinion comments while serving as an Election Judge.
3. I agree to be courteous, respectful and to assist all voters regardless of national origin, physical challenge or proficiency in the English language.
4. I agree to wear the name and party identification supplied by the Larimer County Elections Department at all times while performing my duties as an Election Judge.
5. I agree to read and study the Election Judge Training Manual. I agree to attend Election Judge Training, so I am prepared to fulfill my responsibility to conduct the election according to federal, state, and local election laws and policies.
6. I understand that I am responsible for the security of election equipment and supplies, and I will handle and monitor all such equipment and supplies exactly as instructed.
7. I agree NOT to bring newspapers, magazines or other public information materials that contain political ads or articles into the voting location.
8. I agree NOT to use my cell phone for personal calls, text messages, or web browsing while performing my duties as an Election Judge in the voting location. I agree NOT to use the election computers for any personal use.
9. I agree NOT to bring any electronic equipment (laptops, iPods, Kindles, etc.) into the voting location.
10. I agree to report immediately to the supervisor any malfunction or possible tampering of voting equipment, unusual or suspicious behavior occurring in the voting location, or any other event or occurrence that may threaten the accurate gathering or sanctity of the vote.

I certify that I am a registered eligible elector in Larimer County; I am a U.S. Citizen; I am physically and mentally able to perform and complete assigned tasks; I will attend a class of instruction; I have never been convicted of election fraud or any other election offense, or fraud; and I am not a candidate nor a member of the immediate family, related by blood or marriage to the second degree, of a candidate on the ballot in the precinct I am serving in.
