Release and Waiver Form

This Release is executed on behalf of the below stated individual, together with his/her spouse, successors, assigns, heirs and legal representatives, collectively "Releasor".

In signing this document, I represent that I am fully knowledgeable of the danger and hazards associated with riding motorcycles, which may include paralysis or death. I certify that I am at least 18 years old and duly licensed and competent to operate a motorcycle, that I will operate it in a safe manner and that the motorcycle is in a safe operating condition. I will be riding on public highways/roads and I am solely responsible to determine the speed and operational characteristics of my vehicle while participating in the event. I certify I have insurance as required by law. If I opt to participate in the alternative "dual sport" route, I also represent that I am fully knowledgeable of the increased risk associated with riding "dual sport" motorcycles, and that the route includes paved and unpaved roads. If I opt to participate in this alternative route, I make the additional certification that I am competent to operate a "dual sport" motorcycle and to operate on unpaved roads.

In consideration of being permitted to participate in the Poker Run for Larimer NYPUM Program motorcycle ride on August 28, 2011 and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, I hereby voluntarily and expressly release, waive and discharge forever Larimer County and all employees, officers and agents ("Releasees"), for any and all loss, liability, injury (including but not limited to disability, paralysis or death) claims of damages, whether caused by negligence or misconduct of Releasees or otherwise, arising out of or in any way in connection with the Poker Run for Larimer NYPUM Program.

Releasor agrees to indemnify Releasees from any loss, liability, damage or cost, including reasonable attorney fees, Releasees may incur due to the Releasor participating in the Poker Run for Larimer NYPUM program, including but not limited to damage caused by Releasor to other participants (or their property) or to others not participating in this event (or their property). Releasor further releases, waives, discharges and covenants not to sue Releasees for any loss, injury or damage arising out of or in any way in connection with the Poker Run for Larimer NYPUM program.

Releasor expressly agrees that this release, waiver and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of Colorado and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue to full legal force and effect.

I understand nothing in this form shall be construed as a waiver of the notice requirements, defenses, immunities and limitations under the Colorado Governmental Immunity Act (Sec. 24-10-101, C.R.S. et. seq.) or of any other defenses, immunities, or limitations of liability available to any of the parties by law.

I acknowledge there will be no County or event personnel on the routes to provide emergency or other services and that I am solely responsible for responding to any accident, event or issue. I acknowledge cell phone service may not be available on all routes.
